**NOTIFICATION**

In continuation of earlier notification Endst. No. IGU/COE/2023/333-339 dated 11.10.2023, it is notified for information of all concerned that offline applications are invited for special chance/mercy chance to the students of UG programmes (B.A./B.Com./B.Sc./BBA/BCA/BJMC for the session 2017-18, B.P.Ed. for the session 2017-18, 2018-19, D.P.Ed. for the session 2017-18, 2018-19, 2019-20, LL.B. 3 year programme for the session 2014-15, 2015-16, 2016-17 & 2017-18 and B.Tech., B.H.M.C.T. & B.Pharmacy 4 year programmes for the session 2016-17 (for UTD only)) who couldn't pass the programme within the admissible chances as per Ordinance(s) of the respective programme, subject to fulfillment of following criterion/conditions:

1. The students who enrolled himself/herself for their particular course in the year as mentioned above for each programme and availed all his/her admissible chances as provided in the scheme of examination/Ordinance, stands availed/exhausted till the last examination i.e. May, 2023 shall only be eligible for this special chance/mercy chance. If anyone who has any admissible chance to pass the degree at his/her credit, as of now, shall not be eligible for this special chance/mercy chance.
2. The students are required to submit the offline request (application) for opening of special chance/mercy chance examination form in the office of Controller of Examinations upto 15.04.2024.
