राजकीय महाविद्यालय बावल की कैंटीन हेतु सत्र - 2022-23 व 2023.24 के लिए निविदाएं आमन्त्रित की जाती है। कैंटीन का ठेका लेने के इच्छुक ठेकेदार जिला रेवाड़ी के स्थाई निवासी हों। उनके द्वारा खाद्य पदार्थों के रेट सील बन्द लिफाफे में अंकित करके प्राचार्य के नाम दिनांक 20.03.2023 को दोपहर 2:00 बजे तक डाक द्वारा अथवा स्वयं उपस्थित होकर कार्यालय में दिए जा सकते हैं। ठेका देते समय ठेकेदार के अनुभव उसके निजी आचरण तथा चाल- चलन पर विशेष ध्यान रखा जाएगा यदि उक्त मदों में किसी प्रकार की शिकायत अथवा कोताही पाई गई तो बिना किसी पूर्व सूचना के ठेका रद्द करने का अधिकार प्राचार्य को होगा। निविदा खोलते समय प्रार्थी की उपस्थिति अनिवार्य है। इस सम्बन्ध में निर्धारित शर्तों की लिखित जानकारी तथा खाद्य पदार्थों की सूची प्राप्त करने हेतु महाविद्यालय कार्यालय में किसी भी कार्य दिवस पर प्रातः 9:00 बजे से साँय 4:00 बजे तक सम्पर्क किया जा सकता है।

Subject: Contract for running of canteen in Govt. College Bawal.

Terms & Conditions:


1. The contractor will be responsible for compliance of all statutory laws.
2. The contractor will display the rate in the canteen premises.
3. The contractor will have to make his own arrangements for transportation of raw material, food items, cooking accessories etc. to the canteen,
4. No assurance can be given for the minimum amount of consumption / sale on account of items given in annexure II which are to be provided in college canteen.
5. The contractor shall use only reputed brands for the various eatables/ Beverage (ISI mark, FSSAI "approved and other mandatory Govt. food Safety/ Quality certificates) for Example Tea, leaves of Brookbond, Tata, Tajmahal or equivalents good quality cooking oil, good quality (Agmark) refine oil (Fortune/ Ginni oil etc. or equivalent) Spices(MDH, Everest brand etc. or equivalent)Rice (Branded only) Tat Snit or other equivalent (Pasteurized toned packaged milk from either Vita/Amul/ Mother Dairy/ National dairy research institute Karnal only will be used powdered sugar will not be used.
6. No person below 18 years of age shall be employed by the contractor for work in the canteen.
7. No kerosene oil/ coal/ shall be used by the contractor in canteen premises will be used for cooking purpose.
8. The contractor as well as his workers will not be allowed to stay in college campus during night. No bathing and washing clothes etc. will be allowed by the workers. The conduct/ character/antecedent and proper bonafide of the workers in the canteen shall be sole responsibility of the contractor. However the contractor should provide the necessary details of all its employees (permanent/ temporary/ casual) to the college.
9. No outsiders related to contractor will not be allowed to sit ideally in the college canteen or elsewhere in college campus.
10. Earnest money of Rs. 5000/- will be deposit by the contractor in cash which will be refunded to unsuccessful bidders.
11. The agreement shall be valid initially up to end of session 2023-24 and it may be extended further with the approval of college council.
12. The price quoted by the lowest bidder L-1 will be made part of the agreement and will be valid up to the end of the college session 2023-24.
13. The electricity charges shall be paid by the contractor on due dates as per actual consumption at the prevailing rates by fixing a sub electric meter by himself.

14. The contractor shall submit an affidavit that none of his relative is a member of college staff.
15. Following facilities will be provided by the college administration and contractor will be responsible for proper handling and safe custody
 - a. College canteen premises.
 - b. Water supply to canteen.
 - c. Electricity and power connection to canteen.
 - d. Furniture.
16. In case of any food poisoning / Contamination the contractor will be held fully responsible and he will bear all the expenses caused due to food poisoning / Contamination to any person/persons.
17. All persons engaged by the contractor shall be the contractors own employees and they will claim no privileges from college administration. The contractor will be directly responsible for the administration of his employees as regards general discipline and behavior.
18. The contractor will be responsible for cleanliness of crockery, cooking utensils, furniture using and for fixtures and fitting etc.
19. The college administration will not provided any cleaning materials and dusters.
20. Very high standards of hygiene and cleanliness shall be observed in the running of canteen.
21. College administration / canteen committee nominees reserve the right to take samples of the edibles/ raw material from the canteen for the purpose of inspection and testing with a view to maintain the quality. Such samples will however be drawn by authorized persons.
22. The contractor will ensure that hazardous of flammable or May intoxicating material is not stored in the canteen premises.
23. The contractor shall be responsible for all damages or losses to college property by the contractor or his staff and shall be liable to make good any such loss or damage except those due to reasonable means or war and tear or such as caused by an act of God.
24. The college administration will not be in any way responsible for any loss or damages accruing to any good, stores or articles that may be kept by the contractor in the canteen premises including kitchen and others rooms.
25. For termination for this agreement one month notice will be required from contractor side in writing. The contractor shall vacate the licensed premises peacefully after the expiry of the license period with all furniture, Millings and other articles provided by college. Decision of principal shall be final and binding upon the contractor. The contractor shall be free to remove

without any damage to the college property the articles that might have been brought by the contractor.

26. Contractor has a bare permission only to run the canteen in the college premises during the contractor period and nothing contained in this document shall be construed as demise in law of said college or any past thereof and shall not give any legal title or interest to the contractor.
27. The price quoted in the financial bid will be final.
28. The contractor shall indemnify the college against all losses, damages compensation etc. under the provision of Haryana shops and essential act of modification if any and other issue relating herein under from time to time.
